

Terms of rental of equipment and participation in paintball game

Please read the terms carefully.

This is regarding your own personal safety!



1	In addition to the terms explained in this agreement, players and renters must follow the instructions given by the instructor.	9	All forms of bodily contact are forbidden in all games of paintball.
2	Markers aren't allowed to be fired off before the instructor has completed all necessary instructions and can only be fired on the test shooting range and/or the playing field designated by the instructor. Hereby it must be observed that the marker can only be fired on the designated playing field while a game is in play.	10	Only paintball markers that comply with 1 kap 2 § of the arms regulation ('vapenförordningen') (1996:70) can be carried and used. Other markers are prohibited to carry, as well as knives.
3	Markers are not allowed to be aimed, or fired, at a person not wearing a protective mask (goggle).	11	The rentor is required to take good care of the rented marker and only use it for intended purposes. The rentor is obliged to pay compensation for damage they have caused to the marker or equipment through intent, carelessness, negligence or unintended usage.
4	Protective masks (goggles) must be worn in the manner shown by the instructor when residing on, or in the vicinity of, the playing field.	12	The rentor participates in the game at their own risk and the lessor is not responsible for any type of injury sustained by the rentor, unless the injury can be considered as a cause of intent or gross negligence on behalf of the lessor.
5	Protective masks (goggles) may only be removed within the assigned area, the so called 'safe zone'. If a person without a mask is on, or in the vicinity of, the playing field the game must stop immediately. If a player breaks this rule on repeated occasions, they may be dismissed from the game with retained responsibility of payment.	13	Individuals under the age of 18 are not allowed to play without their caregiver's written consent and acceptance of the above terms and conditions.
6	The vegetation in, or around, the paintball field may not be cut down, torn down, or damaged in any other way. Players who damage the vegetation are liable to compensate for the damage caused.	14	Persons under the age of 15 are not allowed to play unless they have received special permission. We accept people as eligible to play the year that they are due to turn 15.
7	The animals that might be residing in, or around, the paintball field must be treated with respect and shooting at them is absolutely prohibited.	15	Only paintballs that are bought on-site can be used at the paintball field.
8	Players must show consideration toward their fellow players.	16	The lessor maintains the right to immediately cancel an ongoing game and dismiss the renter if the above terms and conditions are not followed. In this case, the renter retains their responsibility of payment.
